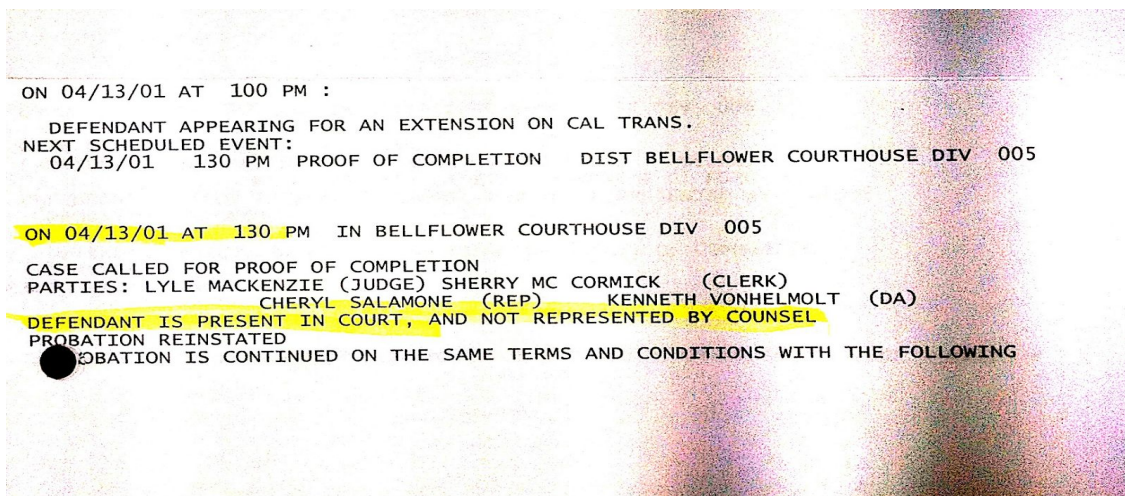
“JAILHOUSE INFORMANT”

JUAN TORRES was a “Friend” of Anthony Contreras since 1999. Juan Torres is a gang member from the “COMPTON 132” street gang who was arrested on 08/11/2001 by Lakewood Sheriff’s Dept. for 211pc (ROBBERY) Charged with Carjacking and Robbery. Eventually, Juan Torres plead guilty to (1) Carjacking, (7) Robberies and (2) Gun Enhancements and sentenced to 30 years in State Prison. **(CASE # NA05000201) (10/08/2001) RT 920,958,992,993**

IN EXCHANGE FOR TESTIFYING IN PEOPLE V. MENDOZA TORRES 30 YEAR SENTENCED WAS REDUCED BY 11 YEARS

- **Juan Torres testified that 3 of the defendants and himself left the house of Contreras about 1:30pm April 13,2001, looking for rival gang members until he was dropped of at 3:30pm (RT 971,973)**

JOSE MENDOZA PROVIDED COURT RECORDS CLEARLY STATING:” DEFENDANT IS PRESENT IN COURT” ON APRIL 13,2001 AT EXACTLY 1:30PM.

JOSE MENDOZA **COULD NOT** OF BEEN IN HIS MOTHER'S VAN, DRIVING THEM AROUND LOOKING FOR RIVAL GANG MEMBERS LIKE JUAN TORRES SAID.

- Juan Torres testified that Jerry Rivas, Anthony Contreras, Jose Mendoza and himself left in the van belonging to “ Jose Mother” (Margaret Shock) (RT 971,973) MARGARET SHOCK (MENDOZA LEGAL GUARDIAN) WAS BORN WITH HIP DYSPLASIA AND CAN NOT GET AROUND IN PUBLIC WITHOUT HER MOTORIZED SCOOTER. SHOCKS VAN IS EQUIPPED WITH A HYDRAULIC LIFT THAT LITERALLY TAKES UP THE WHOLE BACK OF HER VAN. THERE'S ABSOLUTELY NO WAY FOR HER TO GET TO COURT WITHOUT HER SCOOTER AND HER VAN EQUIPPED TO TRANSPORT IT.



(IMAGE SHOWS THE EXACT SAME SCOOTER AND HYDRAULIC LIFT SYSTEM AS IN SHOCKS VAN)

- Juan Torres testified that he “Saw 3 guns underneath the front passenger seat” of the van. “None of them were a .25 caliber” (RT 941-942,1205)

- **THE YEAR, MAKE AND MODEL OF MARGARET SHOCKS VAN**



HAS A FACTORY MADE COMPARTMENT BUILT INTO THE BOTTOM OF THE PASSENGER SEAT, THEIR IS NO WAY 3 GUNS WOULD FIT.

- **Juan Torres testified that there was no way he could of been there during the murder because he had to “Be at work by 4pm at El pollo loco” (RT 923,930,970,973,1081-1082)**

PROOF THAT JUAN TORRES LIED ABOUT GETTING DROPPED OF AT 3:30PM ON APRIL 13, 2001 BECAUSE HE NEEDED TO BE TO WORK AT 4PM. TIME SHEETS FROM EL POLLO LOCO PROVE THAT JUAN TORRES DIDN'T WORK AT ALL ON THE 13.
